Quit Claim Deed.

The grantor Philip Aaron Larsen of Underwood, in the county of Skamania, and state of Washington, for the consideration of Four hundred Dollars in hand paid, conveys and quitclaims to Lewis A. Larsen also of Underwood, Washington, all interest in the following described real estate situated in the county of Skamania, State of Washington, to-wit:

All land lying and being south of the Evergreen State Highway and located in the tract of land hereinafter described; also the undivided one-half interest in and to all those certain springs of water located north of the said Evergreen State Highway on the tract of land hereinafter described, with the land under the same, together with the right of entering upon said lands of the grantor for the purpose of constructing and maintaining an aqueduct or pipe line for the purpose of conducting the water from the said springs to the dwelling house and other buildings of the grantee located south of said Evergreen Highway on the tract of land first herein above described and conveyed, hereby granting and conveying to the said grantee, his heirs administrators, executors and assigns, the free and unrestricted right to obtain from said springs so much of said water as may benecessary to supply the needs of said premises of the grantee for domestic use, not exceeding one-half (2) the natural flow of said springs.
