RIGHT-of-WAY DEED (Pipe Line)

THIS INDENTURE made the 25th day of May, in the year one thousand nine hundred and forty three, between John Stenger of the County of Clark, State of Washington, Grantor, party of the first part, and the Secretary of Agriculture of the United States Department of Agriculture for and in behalf of the United States of America, Grantee, party of the second part, WITNESSETH:

That for and in consideration of One Dollar (\$1.00) in hand paid, receipt whereof is hereby duly acknowledged, the party of the first part does hereby grant, bargain, sell, convey and confirm unto the United States of America an easement and right-of-way in gross over the following tract, lot, piece or parcel of land, situate, lying and being in the County of Skamania, State of Washington, and bounded and particularly described as follows:

Southeast Quarter ($SE^{\frac{1}{4}}$) Northeast Quarter ($NE^{\frac{1}{4}}$) of Section 30, Township 7 North, Range 5 East, Willamette Meridian.

The said right-of-way hereby granted is for the construction, maintenance and full, free and quiet use and enjoyment by the United States of America of a small reservoir and a pipe line, being thirty (30) feet in width, and traversing the above described premises, according to the following general course and direction, to-wit:

Beginning at a point approximately 480 feet West and 50 feet North of the quarter corner common to Sections 29 and 30 of Township 7 North, Range 5 East, Willamette Meridian.

The right of way follows a general Southwesterly direction through a portion of the 40 acre tract described as the SE¹/₄ NE¹/₄ of Section 29 for a distance of approximately 50 feet to the South line of above 40 acre tract.
