WARRANTY DEED

THE GRANTOR, MOFFETTS HOT SPRINGS COMPANY, a Washington corporation, for and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, hereby conveys and warrants unto MARION I. JOHNSTON, a single woman, hereinafter referred to as the grantee, the following described real property situated in the County of Skamania, State of Washington, to-wit:
