Edith Wicher to Carl E. Wicher

Statutory Quit Claim Deed

The Grantor Edith Wicher for and in consideration of One Dollars (\$1.00) convey and quit claim to Carl E. Wicher all interest in the following described real estate, situated in the County of Skamania State of Washington:

Beginning at a point on the West boundary line of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, which said boundary line intersects with the center of the channel of Washougal River; thence in an easterly direction following the channel of said Washougal River to a point 700 feet East of the West boundary line of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, which last-mentioned point is the place of beginning of the tract herein described, also which last-mentioned point is the Southeast corner of a tract of land heretofore sold by the first party herein to Howard W. Dummert on conditional sales contract; thence North parallel with the west boundary line of said Section 34, Township 2 North, Range 5 East of the Willamette Meridian 435 feet more or less to a point in the center of a private road running Easterly and Westerly as now staked out and which said point is 700 feet East of the West boundary line of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, and which said last-mentioned point is the Northeast corner of said tract of land sold to said Howard W. Dummert, as aforesaid; thence running in an Easterly direction along the center line of said private roadway to a point in the center of said private road 800 feet East of the West boundary line of said Section 34, Township 2 North Range 5 East of the Willamette Meridian, which last mentioned point is the Northwest corner of a tract of land heretofore conveyed by the first party herein to Doris Lindsay; thence South parallel with the west boundary line of Section 34, Township 2 North, Range 5 East of the Willamette Meridian 435 feet more or less to a line in the center of said Washougal River and which said point is 800 feet east of the West boundary line of said Section 34, Township 2 North, Range 5 East of the Willamette Meridian, and which said point is also the Southwest corner of said tract of land heretofore conveyed to said Doris Lindsay; thence Westerly following the center of said channel of said Washougal River 100 feet more or less to a point of beginning, all situated in the Southwest Quarter of the Northwest Quarter of Section 34, Township 2 North, Range 5 East of the Willamette Meridian.
