Swisher, a single woman party of the second part, have GRANTED, BARGAINED and SOLD, and by these presents dom GRANT, BARGAIN, SELL and CONVEY unto the said party of the second part, and to her heirs and assigns, the following described real property, situate, lying and being in the County of Skamania State of Washington, to-wit:

Beginning at the Southwest corner of the Northwest quarter (NW<sup>1</sup>) of Section 36, Twp. 3 North of Range 7 East W.
