Witnesseth, That, whereas, at a public sale of real property held on the 28th day of August, A. D. 1937, pursuant to a real property tax judgment entered in the Superior Court in the County of Skamania on the 28th day of August, A. D. 1937, in proceedings to fore-close tax liens upon real property and an order of sale duly issued by said Court of Skamania County, Washington duly purchased in compliance with the laws of the State of Washington, the following described real property, to-wit:
