POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, Roy H. Stein of Underwood, Washington, being about to enter the armed forces of the United States and about to leave home, hereby appoint my wife, Frances L. Stein, to be my attorney in my name, and on my behalf to manage and cultivate, or let upon lease for such period and upon such terms as she shall think fit, and to receive the rents of any or all of my lands, houses, and other buildings, or any part thereof; to cut timber for sale or repairs, and to erect, pull down, and repair buildings on any part of my real estate; to insure any such buildings against loss or damage by fire, and to make arrangements with tenants, and to accept surrenders of leases, and generally to deal with my real estate, or any part thereof, as effectually as I myself could do; and also to take all lawful proceedings by way of action, or otherwise, for recovery of rent in arrear, or for eviction of tenants; to commence and carry on, or to defend at law or in equity, all actions, suits, and other proceedings touching my real estate or any part thereof, or touching anything in which I or my real or personal estate may be in anywise concerned; and also to de-
