Berrong and Edna Berrong, husband and wife, in consideration of \$1.00 and other valuable consideration, the receipt of which is hereby acknowledged, hereby grant unto Northwestern Electric Company, a Washington corporation, its successors and assigns, an easement and right-of-way for an electric transmission line consisting of two (2) poles and one (1) guy anchor, together with overhang of wires, upon, over and across the following described property situate in Skamania County, State of Washington, to-wit:

The West half ($W\frac{1}{2}$) of the West half ($W\frac{1}{2}$) of Northeast quarter ($NE\frac{1}{4}$) of Section 15, T 3 N, R 10 E. W. M.;

said two (2) poles and one (1) guy anchor to be placed upon said above described property as shown by attached Plat PNA 1981, which is made a part of this instrument.

To Have and To Hold said easement and right-of-way unto the said grantee, its successors and assigns, together with the right of ingress and egress to and from said right-of-way, for so long as the grantee shall require the same for the purpose of the erection, construction, maintenance, and operation thereon of said facilities; also the right to cut and keep cut such trees and brush as now or may hereafter interfere with the maintenance of said transmission lines.
