This Indenture, made this 30th day of July, 1943, by and between Herman Osmond, the duly appointed, qualified and acting Administrator of the estate of Charles E. Holtgreive, deceased, party of the first part, and Lee M. Miller, party of the second part,

Witnesseth.

That, whereas, on the 18th day of July, 1943, the Judge of the Superior Court of the State of Washington, for the County of Clark, made an order authorizing the said party of the first part to sell, at public sale, certain real estate of the estate of Charles E. Holtgreive, also known of record as Charles E. Holtgreive, deceased, situated in Skamania County, State of Washington, which said order of sale is now on file and of record in the office of the County Auditor for Clark County, Washington, and,
