Starting at a point 200 feet North of the Southwest corner of Lot 8 of Stevenson Park Addition; thence South 63° 50' East 158.7 feet; thence South 103.3 feet thence North 58° 52' East 38 feet; thence North 24° 48' East 124.8 feet; thence North 16° 17' East 400 feet; thence North 74° 52' West 351 feet; thence South 438 feet to the point of beginning being all the sub-division of Lot 8 of the Stevenson Park Addition as recorded at page 70, Plat Book A records of said Skamania County.

Excepting therefrom lot 1 in Block 1 of said subdivision of Lot 8; and also except lots 2 and 3 and that portion of lots 7, 8, and 9 now owned by the Grantees and particularly described in deed from F. The Grantor, Northern Pacific Railway Company, a corporation organized under the laws of the State of Wisconsin, for and in consideration of One Dollar (\$1), receipt whereof is hereby acknowledged, conveys and quitclaims unto Weyerhaeuser Timber Company a corporation organized under the laws of the State of Washington, grantee, its successors and assigns, all interest in the following described real estate, to-wit:

All of fractional Sections five (5) and seven (7), all of Sections nine (9) and seventeen (17), all of fractional Section nineteen (19) and all of section twenty-one (21), in Township nine (9) North, Range five (5) East of the Willamette Meridian containing three thousand nine hundred thirty-nine and forty-two hundredths (3,939.42) acres, more or less.

Subject, however, to the rights granted the United States of America under easement deed dated April 3, 1919 to operate and maintain a telephone line as now constructed over and across the south half of north half (S $\frac{1}{2}$ of N $\frac{1}{2}$) of said Section 17 and lots one (1), two (2), three (3) and four (4) of said section 19, and to an easement in the public for any public roads heretofore laid out or established, and now existing over and across any part of the premises.

Said land has been heretofore conveyed by the grantor to the grantee by Warranty Deed, and this deed is given to confirm title in the grantee, and is given without actual consideration, and no Internal Revenue stamps or State Conveyance Tax stamps are required.
