BILL OF SALE OF MAPLE AND ALDER LUMBER

THIS INDENTURE WITNESSETH: I, B. A. GARNER, BEING FULLY AUTHORIZED TO SELL THE LUMBER PRODUCTS OF THE SAW MILL OF GARNER & MILLISON IN SKAMANIA COUNTY, WASHINGTON, OWNED AND OPERATED BY W. C. GARNER, B. A. GARNER AND JOHN MILLISON PARTNERS, DO HEREBY SELL AND ASSIGN TO HEYWOOD-WAKEFIELD COMPANY OF 1190 MACADAM STREET, PORTLAND, OREGON, ALL OF THE MAPLE AND ALDER LUMBER NOW STRIPPED AND PILED FOR DRYING AT THE MILL OF GARNER & MILLISON ON THE LANDS OF THOMAS SHEPHERD NEAR THE STEEL BRIDGE CROSSING OF THE WASHOUGAL RIVER, NAMELY, IN TEN PILES NUMBERED FROM ONE TO TEN CONSECUTIVELY AND AMOUNTING TO APPROXIMATELY FIFTEEN THOUSAND FIVE HUNDRED FEET B.M., FOR THE SUM OF TWO HUNDRED FIFTY DOLLARS (\$250.00), RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED.

THE SAID HEYWOOD-WAKEFIELD COMPANY WILL PAY AN ADDITIONAL AMOUNT, INCLUDING FREIGHT CHARGES, UPON THE SCALE THEN MADE, WHICH SHALL, WITH THE AMOUNTS PREVIOUSLY PAID, AGGREGATE \$35.00 PER THOUSAND FEET DELIVERED.

AND FAILING TO MAKE SUCH DELIVERY THE HEYWOOD-WAKEFIELD COMPANY IS HEREBY EMPOWERED TO TAKE POSSESSION OF SAID LUMBER. TRANSPORT IT TO PORTLAND, OREGON TO ITS FACTORY AND AFTER PAYING ALL COSTS AND EXPENSES, TURN OVER TO GARNER & MILLISON THE BALANCE, IF ANY, DUE UNDER THE CONDITIONS ABOVE SET FORTH.
