WE ACKNOWLEDGE THE RECEIPT OF ONE HUNDRED TWENTY-FIVE DOLLARS AS ADVANCE PAYMENT BY THE SAID HEYWOOD-WAKEFIELD COMPANY UPON THE SAME.
