 NOW THEREFORE: THIS ASSOCIATION IS FORMED FOR THE PURPOSE OF PERFECTING THE TITLE TO SAID CLAIMS AND PROPERTIES OF WORKING AND DEVELOPING THEM IN A MINERLIKE MANNER, AND OF ESTABLISHING AN ADMINISTRATIVE CODE OF PROCEEDURE AND OF BUSINESS MANAGEMENT CALCULATED TO INSURE ECONOMY AND EFFICIENCY. THESE ARE CONTIGUOUS CLAIMS. THE OFFICERS OF THIS ASSOCIATION SHALL BE A PRESIDENT, A SECRETARY, A VICE-PRESIDENT, AND A TREASURER. THE OFFICE OF SECRETARY AND TREASURER MAY BE HELD BY THE SAME PERSON, SAID OFFICERS SHALL CONSTITUTE THE EXECUTIVE BOARD OF THE ASSOCIATION THEY SHALL HAVE POWER TO TRANSACT AND CARRY ON ALL ITS BUSINESS AND TO APPOINT ALL NEEDED ASSISTANTS AND REMOVE THEM AT WILL.

IT IS AGREED IN VOTING ON ANY BUSINESS WHATEVER AND IN SHARING IN THE PROFITS, THE VOTE AS WELL AS THE SHARES, WILL BE BASED ON THE INTEREST EACH HAS CONVEYED TO THE ASSOCIATION IN TERMS OF CLAIMS CONVEYED.

IT IS FURTHER AGREED THAT ALL INTEREST HELD BY DR. C. O. NELSON, AS TRUSTEE, HIS SUCCESSORS AND ASSIGNS, SHALL SHARE IN DIVIDENDS PRO-RATA ON AMOUNT OF CLAIMS CONVEYED TO SAID TRUSTEE.

IN CASE OF DR. C. O. NELSON'S DEATH, THE MEMBERS OF THE CRESCENT MINING ASSOCIATION, HEREBY AGREE THAT ALL INTERESTS HELD IN TRUST SHALL BE HELD BY THE PERSON WHO SUCCEEDS SAID NELSON AS TRUSTEE; SAID SUCCESSOR TO BE CHOSEN BY THE SKAMANIA MINING ASSOCIATION.

IN CASE OF DEATH OF R. F. BROWN, WHO HOLDS POWER OF ATTORNEY IT IS FURTHER AGREED THAT THE SKAMANIA MINING ASSOCIATION MAY APPOINT HIS SUCCESSOR.

IT IS FURTHER AGREED THAT CHARLES S. GILCHRIST; J. J. O'NEILL ROSS W. DAUBNEY, JOHN ARTHUR AND GERTRUDE SPAULDING HOLD INTERESTS IN THIS ASSOCIATION BY VIRTUE OF AN AGREEMENT THAT CERTAIN CLAIMS YET TO BE LOCATED SHALL BE LOCATED IN THEIR RESPECTIVE NAMES AND AFTER LOCATION SHALL BECOME A PART OF THE CRESCENT MINING ASSOCIATION UNDER THE SAME TERMS AND CONDITIONS AS ARE THE ABOVE NAMED PARTIES.

IT IS FURTHER AGREED THAT BY VIRTUE OF THE POWER OF ATTORNEY HELD BY R. F. BROWN GRANTED BY EACH OF THE ABOVE NAMED PARTIES THE SAME HEREBY IS MADE IRREVOCABLE, AS BEING COUPLED WITH AN INTEREST IN EACH AND ALL OF THE CLAIMS NAMED ABOVE.
