Schatz, husband and wife, in consideration of the sum of \$3,000.00 in hand paid, receipt whereof is hereby acknowledged, do hereby bargain, sell and convey unto Louis Schaefer and Mildred Schaefer, of Vancouver, Clark County, Washington, that certain cabin or cottage located upon the property of the Wauna Lake Club in Skamania County, Washington, together with all of the household goods, furnishings and equipment on hand therein as of September 1, 1944, except the following: one fish pole, quilts, several blankets and a portion of the kitchen cutlery.

Also, the vendors convey to the vendees first mortgage bonds of the par value of \$650.00 of said Wauna Lake Club, together with all unmatured coupons attached thereto, together with fire insurance policy upon the building, dock or wharf, boat, and any and all rights that the vendors may now have in and to the land upon which the house is situated or the premises surrounding the same heretofore allotted by said club to the use and benefit of the vendors.
