with the appurtenances, for the term of ten years from the 1st day of April one thousand nine hundred and thirty-two, at the annual rent or sum of ten (\$10.00) Dollars, payable in rold coin of the United States of America and to be paid in advance, on the 1st day of April of each and every year during said term of ten years.

And it is hereby agreed, that if any rent shall be due and unpaid, or if default shall be made in any of the covenants herein contained, or breach thereof, then it shall be lawful for the said lessor to re-enter the said premises and to remove all persons and goods therefrom; and the said lessee do hereby covenant, promise and agree to pay the said lessor the said rent in the manner hereinbefore specified and not to let or underlet the whole or to y part of the said premises without the written consent of the said lessor, nor to assign this lease or any part thereof without said written consent; nor shall the interest of the lessee be transferred by operation of law through any execution sale or bankruptcy proceeding; and at the expiration of the said term, the said lessee will quit and surrender the said premises in as good state and condition as reasonable use and wear thereof will permit (damages by the elements or fire excepted) It is further understood: that at the expiration of this lease, the State of Washington will hold title to the structures and improvements placed by iton the above described tract of land, and will be permitted to remove same from said tract of land.
