Mobley of Skamania County the party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and deliver unto the said party of the second part, the following described personal property now located at Government Lot 2, in Section 2, Twp. 3 North, Range 10 E.W.M. in the County of Skamania and State of Washington, to-wit:

That certain 1 story frame building (being a three room cabin or dwelling house) 16 by 24 feet, with asphalt roofing and Asphalt shingle siding, situate and located upon the tract of land described in that certain permit or lease, dated June 27th, 1945, made by and between Northwestern Electric Company of the one part and Thomas H.
