BILL OF SALE

County of Skamania, State of Washington, the party of the first part, for and in consideration of the sum of Four hundred fifty Dollars lawful money of the United States of America, to him in hand paid by Betty Fowler of Seattle, Washington, the party of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell and deliver unto the said party of the second part, the following described personal property now located in the County of Skamania and State of Washington, to-wit: One complete set of house moving dollies, One complete set of screw jacks and hydraulic jacks, six hand shovels, four picks, one saw mill consisting of two circular saws, blocks and carriage, two gasoline motors and shaftings and pulleys, all located and stored in Skamania County, Washington.

TO HAVE AND TO HOLD the same to the said party of the second part, her heirs, executors, administrators and assigns forever. And said party of the first part, for himself, his heirs, executors, administrators, covenant and agree to and with the said party of the second part, her executors, administrators and assigns, that said party of the first part is the owner of the said property, goods and chattels and has good right and full authority to sell the same, and that he will warrant and defend the sale hereby made unto the said party of the second part, her executors, administrators and assigns, against all and every person or persons whomsoever, lawfully claiming or to claim the same.
