## MEMORANDUM OF LEASE

THIS INDENTURE, made and entered into this 20th day of September 1935, by and between George F. Christensen and Minnie Christensen, his wife of Stevenson, Washington, hereinafter called the Lessor, and Shell Oil Company, a California Corporation, hereinafter called the Lessee.

WITNESSETH: That for the term and upon the terms and conditions set forth in Service Station Lease bearing date September 20th, 1935, from the Lessors to the Lessee, the Lessors have leased, demised and let, and do hereby lease, demise and let unto the Lessee, the following described real property, situated, lying and being in the County of Skamania, State of Washington more particularly described as follows, to-wit:

"Commencing at the S.E. corner of Block eight (8) of the Town of Stevenson, according to the official plat thereof on file and of record in the office of the County Auditor of Skamania County, Washington; thence N 34° 30' W 30 feet more or less to the outside line of the Southerly wall of the tile building on land heretofore conveyed to the Northbank Theatre and Realty Company, a corporation, by deed recorded at page 213 Book "U" of deed records of Skamania County, Washington; thence S 55° 30' W along the other line of the edge of the above mentioned theatre building a distance of eighty (80) feet, thence N 34° 30' W 33 feet; thence S 55° 30' W 50 feet; thence S 34° 30' E 63 feet more or less to the N line of Second Street; thence N 55° 30' E 130 feet to place of beginning."

Together with all tools, equipment and improvements now located on said premises, listed on the inventory marked Exhibit "A" attached to said lease and made a part thereof, and all other buildings, improvements and equipment now located on said premises, or which may hereafter during the term hereof be placed on said premises/
