CAMPBELL and LUCILLE CAMPBELL, husband and wife, of 500 West 34th Street, Vancouver, Washington, the following described personal property situate in the County of Skamania, State of Washington, to-wit:

Beginning at a point in the Northeast quarter of the Southeast quarter of the said Section 7 marking the intersection of the center of the channel of Wind River with the Southwesterly right of way line of State Highway 80, said point being on the right of way of the existing suspension bridge over Wind River; thence following the Southwesterly right of way line of State Highway 80 as presently located and established in a Northwesterly direction to intersection with the Southerly right of way line of State Highway 80 Detour; thence following the Southerly right of way line of State Highway 80 Detour as presently located and established in a generally westerly direction to intersection with the center of the channel of Wind River; said point being on the right of way of the existing water level bridge over Wind River; thence following the center of the channel of Wind River in an Easterly direction to the point of beginning.

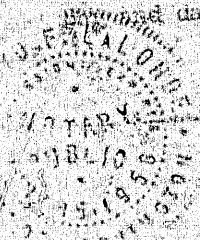
