 warrant and defend the sale of said property, goods and chattels.

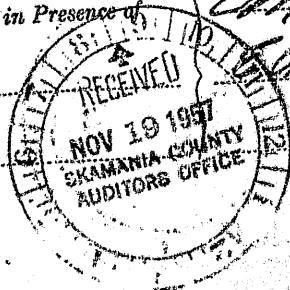
