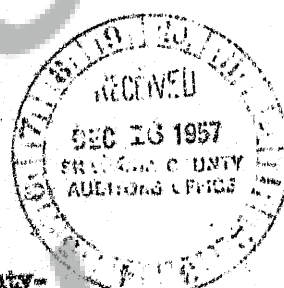


BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS: That Northwest District Council,
Assemblies of God, the party of the first part, for and in consideration
of the sum of THREE HUNDRED DOLLARS, to them in hand paid by Joseph
Helmer, the party of the second part, the receipt whereof is hereby
acknowledged, does by these presents grant, bargain, sell and convey
unto the said party of the second part, their heirs, executors, adminis-
trators and assigns the following described personal property, now being
situated in the Town of North Bonnaville, County of Skamania, State of
Washington, to-wit:

A certain residence building located upon a certain parcel
of leased land leased from Battle L. Brown, a widow, which
said lease is being assigned and transferred to the party of
the second part with this Bill of Sale, said property being
described as follows:

A plot of ground twenty-five (25) feet north and south, by
seventy-five (75) feet east and west, known as Lot number
fifteen, (#15) of Block number four (4) as shown on the
plat of Brown's Court and in the Brown Tract, a part
of the old Chippewa Indian Reservation, beginning at a
point in the North line of State road number eight (#8),
three hundred and thirty (330) feet west of Section line
between Section number one (1) and number twenty-
two (22) Township North (2) Range Seven (7) East W. M.
in Skamania County, Washington.



TO HAVE AND TO HOLD the same to the said party of the second part,
their heirs, executors, administrators and assigns forever. And the
first party does for their heirs, executors and administrators, covenant
and agree to and with the said party of the second part, their heirs,
executors, administrators and assigns, to warrant and defend the sale of
the said property, goods and chattels hereby made unto the said party of
the second part, their heirs, executors, administrators and assigns, against
all and every person and persons whomsoever lawfully claiming or to claim
the same.
