



BILL OF SALE.

THIS INDENTURE WITNESSETH, That for and in consideration of the sum of ELEVEN THOUSAND DOLLARS (\$11,000.00), the receipt whereof is hereby acknowledged, The Hedberg Lumber Company, a co-partnership, and I, the undersigned Elmer Hedberg, partner in and manager of the said co-partnership, do hereby grant, bargain, sell, transfer and deliver unto Cornelia S. Ackley, the following described personal property, now being and situate in the State of Washington, Skamania County, to-wit:

One used Coe Lathe, size 135" x 110" Swing, equipped with 7" Hydraulic Spindles (New Hydraulic System), new bearings throughout, Roller Bar Case, one complete set Elford Positive Veneer Knife Clamps , and further,

in consideration of the said sum of ELEVEN THOUSAND DOLLARS (\$11,000.00) paid to the said Hedberg Lumber Company, a co-partnership, and to me, as hereinabove set forth as being paid by said Cornelia S. Ackley, I do hereby convey, sell, assign, transfer and set over to the said Cornelia S. Ackley, her heirs, assigns and administrators and executors, all and entire of the right of the said Hedberg Lumber Company, a co-partnership, together with all of my right, title and interest, in and to that certain Conditional Contract of Sale, executed by and between Elmer Hedberg and Gunnard Hedberg, a co-partnership doing business as Hedberg Lumber Company, Brookings, Oregon (designated "SELLER") and Skamania Loggers and Contractors, Inc., a Washington Corporation of Stevenson, Washington (designated PURCHASER), in Vancouver, Washington, on January 26, 1962, filed for record in the office of the County Auditor, Skamania County, State of Washington, on February 5, 1962, number 59481, and we, the said Hedberg Lumber Company, a co-partnership, and Elmer Hedberg, grants, bargains, sells and conveys unto the said Cornelia S. Ackley, the aforesaid Coe Lathe, as hereinabove described, and as described in said conditional sale contract, filed and recorded as hereinbefore set forth, and all and entire of our right, title and interest thereto, all jointly and severally, unto said Cornelia S. Ackley, forever.

TO HAVE AND TO HOLD, the same unto the said Cornelia S. Ackley, her executors, administrators and assigns, forever. And the Hedberg Lumber Company, aforesaid co-partnership, and I, Elmer Hedberg, do hereby covenant and agree to and with said Cornelia S. Ackley, that we, or I, own the aforesaid Coe Lathe; that the same is free from encumbrances except as described and set forth in the aforesaid Conditional Sale Contract #59481, office of County Auditor of Skamania County, Washington, and filed for record therein as hereinabove set forth, that we, or I, have good right to sell the same, and that we, or I, our or my heirs, executors, administrators and assigns shall warrant and defend the same against the lawful claims and demands of all persons whomsoever.
