BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS: That WILLIAM F. PERRY, a widower, of White Salmon, County of Klickitat, State of Washington, the party of the first part, for and in consideration of the sum of One Dollar (\$1.00), lawful money of the United States of America, to him in hand paid by ALICE ARTHUR MOORE, the party of the second part, the receipt of which is hereby acknowledged, does by these presents grant, bargain, sell and deliver unto the said party of the second part, the following described personal property now located at Northwestern Lake, County of Skamania, and State of Washington, on the following described tract:

All right, title and interest in and to the improvements and fixtures contained therein, consisting of a cabin upon the following described real estate situated in Skamania County, State of Washington, as follows, to wit:

A tract of land being 75 feet more or less in its northerly and southerly dimension and 250 feet more or less in its easterly and westerly dimension and being within Government Lot 2, Section 2, Township 3 North, Range 10 East, W.M., in Skamania County, Washington, as shown on the plat attached hereto and made a part hereof, said tract being referred to on the Company's records as Northwestern Lake Cabin Site No. 15.

TOGETHER with stove, refrigerator, hot water tank, tools, and all other miscellaneous contents therein, and nothing by way of exclusion.

TO HAVE AND TO HOLD the same to the said party of the second part, her heirs, executors, administrators and assigns forever. And said party of the first part, for his heirs, executors, administrators, covenants and agrees to and with the said party of the second part, her executors, administrators and assigns, that said party of the first part is owner of the said property, goods and chattels and has good right and full authority to sell the same, and that he will warrant and defend the sale hereby made unto the said party of the second part, her executors, administrators and assigns, against all and every person or persons, whomsoever, lawfully claiming or to claim the same,
