AGREEMENTS, Made and entered into the 7th day of April, 1949, by and between Cora May Willson and George Wilson , wife and husband of _____, hereinafter called lessor (whether one or more), and Jack Woodruff, Roy Woodruff and Robert Woodruff, hereinafter called lessee:

WITNESSETH: That the said lessor, for and in consideration of One (\$1.00) Dollars, cash in hand paid, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee for the sole and only purpose of mining and operating for oil and gas and of laying pipe lines, and of building tanks, power stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of kamania, State of Washington, described as follows, to-wit:

The Southwest Quarker of the Northeast Quarter excepting the following: Begin at a point 997 feet East on the true subdivision line from the Northwest corner of the Southwest of the Northeast; thence South along said subdivision line 660 feet; thence East 330 feet; thence North 660 feet; thence West 330 feet to the beginning; also excepting 2.35 acres thereof owned and occupied by the S. P. & S. Railroad; also excepting begin, at the Northeast corner of the Southwest of the Northeast; thence South on subdivision line 660 feet to the initial point; thence East 330 feet to the County Road known as Skelton Cutoff; thence Southerly along said road to intersection with North line of State Highway No. 8; thence Easterly along Highway to the East line of the Southwest Quarter of the Northeast Quarter; thence North to the point of beginning.

In consideration of the premises the said lessee covenants and agrees:

1st. To deliver to the credit of lessor, free of cost, in the pipe line to which lessee may connect wells on said land, the equal one-eighth part of all oil produced and Mileciasents a decree

saved from the leased premises.

2nd. To pay lessor one-eighth (1/4) of the gross proceeds each year, payable quarterly, for the gas from each well where gas only is found, while the same is being used off the premises, and if used in the manufacture of gasoline a revalty of one-eighth (1/8), payable monthly at the prevailing market rate for gas; and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling on said land during the same time, by making less r's own connections with the well at lessor's own risk and expense.

3rd. To pay lessor for gas produced from any oil well and used off the premises or in the manufacture of gasoline or any other product a royalty of one-eighth (1/8) of the proceeds, at the mouth of the well, payable monthly at the prevailing market rate.

If no well be commenced on said land or within the boundaries of the lands described as follows: as above described on or before the First day of May, 1950, this lease shall terminate as to both parties, unless the lessee shall on or before that date pay or tender to the lessor or to the lessor's credit in the Bank of Stevenson Bank at Stevenson, Washington, or its successors, which shall continue as the depository regardless of changes in the ownership of said land, the sum of twenty five cents per acre, which shall operate as a rental and cover the privilege of deferring the commencement of a well for twelve months from said date. In like manner and upon like payments or tenders, the commencement of well may be further deferred for like periods of the same number of months successively. And it is understood and a red that the consideration first recited herein, the down payment, covers not only the privilege granted to the date when said first rental is payable as aforesaid, but also the lessee's option of extending that period as aforesaid, and any and all other rights conferred.

Shouddthe first well drilled on the above described land be a dry hole, then, and in that event, if a second well is not commenced on said land within twelve months from the expiration of the last rental period for which rental has been paid, this lease shall terminate as to both parties, unless the lessee on or before the expiration of said twelve months shall resume the payment of rentals, in the same amount and in the same manner as hereinbefore provided. And it is agreed that upon the resumption of the payment of rentals as above provided, that the last preceding paragraph hereof governing the payment of rentals and the effect thereof, shall continue in force just as though there had been no interruption in the rental payments, and if the lessee shall commence to drill a well within the term of this lease or any extension thereof, the lessee shall have the right to drill such well to completion with reasonable diligence and dispatch, and if oil or gas, or either of them, be found in paying quantities, this lease shall continue and be in force with like effect as if such well had been completed within the term of years first mentioned.
