AGREEMENT, Made and entered into the 25th day of "pril, 1949, by and between Anna Fredrikson, wisow, of Ekamania, Washington, hereinafter called lessor (whether one or more) ard Jack Woodruff, Roy Woodruff and Robert Woodruff, hereinafter called lessee:

WITNESSETH: That the said lessor, for and in consideration of One (\$1.00) Dollars, eash in hand paid, the receipt of which is hereby acknowledged, and of the covenents and agreements hereinafter contained on part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee for the sole and only purpose of mining and operating for oil and gas and of laying pipe lines, and of building tanks, power stations and structures thereon to

produce, save and take care of said products, all that certain tract of land situate in the County of Ckamania, State of Washington, described as follows, to-wit:

The East one-half of the Northeast Quarter of the Northeast Quarter of Section 34, Cownship 2 N, Range 6 EWM, and containing 17.5 acres, more or less. It is agreed that this lease shall remain in force for a ser of Ten years from this date, and as long thereafter as oil or gas or either of them is produced from said land by lessee.

In consideration of the premises the said lossee covenants and agrees:

lst. 4. deliver to the credit of lessor, free of cost, in the pipe line to which lessee may connect wells on said land, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. To pay lessor ~~-eighth (1/3) of the gross proceeds each year, payable quarterly, for the gas from each well where gas only is found, while the same is being used off the premises, and if used in the rufacture of gascline a royalty of one-eighth (1/8), payable monthly at the prevailing market rate for gas; and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling on said land during the same time, by making lessor's own connections with the well at lessor's own risk and expense.
