CONTRACT OF SALE

TO WHOM IT MAY CONCERN:

For and in consideration of the sum of Two Hundred Dollars (200.00) paid in hand, I Frank Cady of Skamania, Wash. do hereby sell to Cora May Santo. Forty Eight per-cent (48% of my total rights which amount to Four and One Sixth per cent, (4 1/6% of all moneys obtained from the production or sale of Natural Gas, Oil or Oil royalties produced from the below described property, jointly owned by Carl Olsen and myself.

Beginning at the center line of section 35, tp. 2 n.r. 6 E.W.M. with a northerly line of right of way of Spokane Portland & Seattle Ry. Company, thence north along the said center line of Section 35; to intersection with a southerly line of State Highway No. 8, thence easterly along southerly of said Highway to center line of channel change of Woodard Creek as described in Deed from Diamond Lumber Co. a Corporation to Spokane Portland & Seattle Ry. Co. Recorded at page 492 Book L of Deeds. thence following the said center line of Channel change of Woodard Creek in a south easterly direction to intersection with east of N.W. 1/4 of the N.E. 1/4 of said section 35, thence south to the northerly line of said S.P. & S. Ry. Co. right of way, thence westerly along the north line of said right of way to the point of beginning, Excepting therefrom portion conveyed to S.P. & S. Ry. Co. for proposed change in channel.

It is furthermore understood and agreed that in event natural Gas or Oil is Found or produced Taxes on said property will be paid by Cora May Santo according, to proportionate share.
