AGREEMANT to C. Sl Hail

THIS AGREEMENT, Made and entered into this 11th day of August 1928 by and cetween Hedwig Nelson, party of the first part, and C. S. Hail party of the second part WITNESSETH That in consideration of the stipulations and Agreements bereinafter mentioned and the payments to be made by the second party, the party of the first part agrees to sell, to the party of the second part his Heirs or assigns the following described real estate situate in Skamania County Washington to wit:

The Southwest quarter of the Northeast quarter of the North east quarter of Sec. one (1) in Township Three (3) North, Range seven and one half (7) Fast, Willamette Meridian,

upon the following terms and conditions. Party of the second part agrees to pay to the party of the first part the sum of Three Hundred and Fifty dollars payable as follows. One Hundred Dollars on the date of this agreement and One Hundred Dollars on the first day of August 1929, One Hundred Dollars on the first day of August 1930 and Fifty Dollars on the first day of August 1931 together with interest thereon at the rate of six per cent per amnum from the 11th day of August 1928 untill paid. In case the purty of the second part shall make the payments aforesaid punctually ant at the times specified, and when the final payment has been made according to this agreement, then the party of the first part will make to party of the second part a good and sufficient deed of conveyance conveying to party on the second part all her right, title and interest in and to the above described real estate. 'But in case the party of the second part shall fail to make the payments aforesaid or any of them, when the same shall become due or fail to pay the interest on said payments, then this agreement shall become null and void and all interest of the party of the second part, in and to the above described real estate shall at once cease and revert the party of the first part the same as if this agreement had never been made.
