the parties of the second part, the receipt whereof is hereby acknowledged, do by these presents bargain, sell and deliver unto the said parties of the second part their executors, administrators and assigns, all of the following described personal property, to-wit:

Four horses, one cow and calf, one truck, one safe and farm implements, and other personal property now situated on a certain farm in Skamania County, Washington, which the party of the first part has this day conveyed to the party of the second part.

To have and to hold the same unto the said parties of the second part, their executors, administrators and assigns forever.

And we hereby covenant with the said parties of the second part that we are the lawful owners of said goods and chattels; that they are free from all incumbrances that we have good right to sell the same as aforesaid, and that we will and our executors and administrators shall warrant and defend the title thereto unto the said parties of the second part, their executors, administrators and assigns against the lawful claims and demands of all persons whomsoever
