This matter coming on regularly for hearing this day and it appearing to the court that on June 28, 1943 judgment in the sum of Five Hundred (\$500) Dollars without interest was entered herein in favor of Wauna Toll Bridge Company, a corporation, and Baker-Boyer National Bank of Walla Walla, Washington a corporation, against the United States of America on account of the taking of a perpetual right of way and easement to flood and overflow the right of way and easement of the respondent Wauna Toll Bridge Company, a corporation, to a low water elevation of 72.5 feet above mean sea level and to a high water elevation of 86 feet above mean sea level, together with the right to go upon and remove from the easement of said Toll Bridge Company timber, brush and driftwood, and it further appearing to the Court that on April 7, 1944 the sum of Five Hundred (\$500) Dollars was deposited by the United States of America in the Registry of this Court for and on account of said judgment, and the court being generally duly advised, now, therefore, it is hereby
