QUITCLAIM DEED.

Know all men by these presents, That Little White Salmon Land Company, a Washington corporation, in consideration of the sum of One (\$1.00) Dollar and other good and valuable considerations to it in hand paid by H. J. Broughton and D. M. Stevenson, co-partners, doing business under the assumed name of Broughton Lumber Company, does hereby remise, release and forever quitclaim unto the H. J. Broughton and D. M. Stevenson, and unto their heirs and assigns, all its right, title and interest in and to the following described real property, situate, lying and being in Skamania County, Washington, and more particularly described as follows, to-wit:

All that part of the $SW^{\frac{1}{4}}$ of $SW^{\frac{1}{4}}$ of section 36, Township 4 north, range 9 east W. M., included in a strip of land 100 feet in width, having 50 feet of such width on each side of the following described center line:

Beginning at a point on the west line of said section 36, 501.24 feet north of the southwest corner thereof, and running thence south 38° 17' 01" east, 21.57 feet; thence on a curve to the left, having a radius of 2546.64 feet and turning through an angle of 10° 00' 02", 444.47 feet; thencesouth 48° 17' 03" east, 149.30 feet; thence on a curve to the right, having a radius of 170 feet and turning through an angle of 25° 09' 52", 74.66 feet; thence south 23° 07' 11" east, 1.82 feet to a point on the south line of said section 36, which is 473.09 feet east of the southwest corner of said section 36;
