Bennett, the executor of this, my last Will and Testament, and I do herein and hereby direct and declare that no bond or bonds shall be required of him from any Court, and that he act and serve as such executor without being required to give or furnish any bond or bonds.

LASTLY: I hereby revoke all former Wills by me made.
