This matter coming regularly before this court on stipulation of the United States of America, petitioner, appearing by John W. Fishburne, Special Attorney for the Department of Justice, and respondents, Wauna Toll Bridge Company, a corporation, and Baker-Boyer National Bank of Walla Walla, Washington, a corporation, appearing by their attorneys, Grosscup, Morrow & Ambler, and Crowe, Stearns & Snyder, and it appearing to this Court that the petitioner, United States of America, filed a petition for condemnation of flowage easement for public use on the 17th day of July, 1937, under the provisions of Sections 591 and 594 Title 33 U.S.C.A., praying for a perpetual easement to flood and overflow the easement and right of way of the Wauna Toll Bridge Company over lands hereinafter described, together with the right to go on the easement of said Toll Bridge Company and remove timber, brush and driftwood; it appearing to the Court that the construction of the Bonneville Dam Project has raised the flow of the Columbia River
