I, Theodore C. Grams, being first duly sworn, on oath depose and say:

That I checked the title to the following-described property in Skamania County, Washington:

That portion of the west half of the northwest quarter and that portion of the southeast quarter of the northwest quarter which lie easterly of a line one hundred feet distant westerly from and parallel to the center of the channel of Woodard Creek, in section 22, township 2 north, range 6 east, Willamette meridian;

That this examination was made in my capacity as clerk, U. S. Department of the Interior, Bonneville Power Administration, and as such clerk I secured certain quitclaims deeds from various heirs of Hiram Bennett, deceased, to Skamania County, Washington, grantee; these deeds were obtained for the purpose of confirming title in Skamania County as trustee for the various taxing units, which title was acquired under foreclosure proceedings in Case No. 2538-C, in the Superior Court of the State of Washington for Skamania County; and not for the purpose of vesting fee simple title in said County, and
