Startzman, have granted, bargained and sold, and by these presents do grant, bargain, sell, and convey to said Howard H. Startzman, his heirs and assigns, all the following bounded and described real property situated in the County of Skamania, State of Washington, to-wit:

The Southeast quarter of the Northeast quarter of Section 16, Township 3 North of Range 10 East of Willamette Meridian;
