KNOW ALL MEN BY THESE PRESENTS, That We, G. E. Bailey and Juanita Bailey, husband and wife, in consideration of the sum of One Dollar to them in hand paid do hereby transfer, sell and assign unto Edward Guy Gahimer and Rose A. Gahimer, husband and wife, all the right, title and interest of the said G. E. Bailey under and by virtue of the terms of a certain written indenture dated July 26th, A.D. 1940, and executed, in duplicate, by J. R. Phillips and Bertha A. Phillips, husband and wife, as parties of the first part, and J. Lowe and Elin Lowe, being husband and wife, wherein the said J. R. Phillips and Bertha A. Phillips, did agree and covenant as follows:-

IT IS UNDERSTOOD AND AGREED that the parties of the first part will furnish water to the dwelling houses and/or cabins upon the plot of land above described for domestic purposes, without charge until a Public Utility takes over. It is also understood that it is contemplated by the parties of the first part that they will sell other lots in the vicinity of said tract of land and will furnish water to this and said other tracts of land in accordance with the rules and regulations of the Public Service Commission and the laws of the State of Washington. That they will take such steps as necessary to conform with the laws, rules and regulations for the furnishing of water to the property aforesaid and will file with the Public Service Commission a schedule of rates in which the base rate for such service to each dwelling shall not exceed the sum of One Dollar per month. The said base rate to provide for the use of not to exceed 7500 gallons monthly consumption per dwelling and/or cabin and provided further that such base rate shall
