Lots Thirty-nine (39), Forty (40), Forty-one (41), Forty-two (42) and Forty-three (43) of Washougal Riverside Tracts, as shown on the duly recorded plat thereof in Skamania County, Washington.

On June 17, 1943, the grantor herein executed and delivered to the grantee herein a deed to the above described real property upon which deed there was placed and cancelled United States Internal Revenue stamps in the amount of \$4.40. The grantee failed to record the deed and the deed was totally destroyed on November 26, 1943 at which time the house of the grantee was burned to the ground. This conveyance is made to take the place of the former/and confirm title in the grantee.
