L. W. Wright being first duly sworn upon oath deposes and says: That he is the grantee named in that certain bargain and sale deed from State of Washington, grantor, to L. W. Wright, grantee, dated April 1, 1941 and recorded April 21st, 1941, in Book 28 of Deeds at page 299 in the Office of the Auditor of Skamania County, Washington, by which deed the State of Washington conveyed to affiant the following described property, to-wit:

Lot 2, Section 28, Township 7 North, Range 5 East of W. M., Skamania County, Washington, containing 25.45 acres, more or less, according to the government survey thereof

and affiant is one of the grantors in that certain warranty deed from L. W. Wright and Ella B. Wright, husband and wife, to O. P.
