County, Washington, to-wit:

Commencing at the point of intersection of the east line of the west half of
Lot three of Oregon Lumber Company's Subdivison of section fourteen in Township
three North of Range Nine East of Willamette Meridian with the north line of
said Lot three, thence west 110 feet along the north line of said Lot 3 to the
initial point of this description, thence south to the south line of said Lot
3, thence westerly along the south line of said Lot 3 to the southwest corner
thereof, thence northerly along the west line of said Lot 3 to the northwest
corner thereof, thence easterly along the north line of said Lot 3 to the place
of beginning.

Subject to and excepting grantors water right upon Fowler Creek passing through
