THE GRANTOR, Raymond Whitlock, dealing with his separate property, in consideration of the sum of one dollar in hand paid, (actual consideration less than \$100.00) does hereby CONVEY and WARRANT unto G. R. Harris and Myrtle L. Harris, husband and wife, GRANTEES, the following described real property in Skamania County, State of Washington, to-wit:

Beginning at the southerly point of Lot 12 Stevenson Park Addition, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington, thence in a northeasterly direction along the Easterly line of said Lot 12 a distance of 175 feet to an iron pipe driven in the ground for the point of beginning of the tract hereby conveyed, the said pipe marking also the northeasterly corner of that tract of land conveyed by W. D. Lucas and Nannie Irene Lucas, husband and wife to G. R.
