White, GRANTEE, the following described real property in Skamania County, State of Washington, to-wit:

BEGINNING at a point 5 rods north of the southwest corner of Section 16, Township 3 North, Range 8 East of Willamette Meridian; running thence East 29 rods, thence north 32 rods, thence west to west line of Section 16; thence south to point of beginning, containing six (6) acres, more or less; ALSO, all of the grantor's right and interest in and to a privilege for a road along a strip of land 30 feet wide, beginning at the southwest corner of the above described land and extending south along the west line of Sections 16 and 21 to the County Road, and also the following described property: BEGINNING at a point 29 rods east and 37 rods north of the southwest corner of Section 16, Township 3 North, Range 8 East of the Willamette Meridian; running thence west to the west line of Section 16, thence 17 rods in a northerly direction along the said west line of Section 16, thence in a
