1. Beginning at the Southwest corner of the northeast quarter of the northeast quarter of section twenty, township three north, range eight, East of the Willamette Meridian; running thence north 15 rods, thence East 40 rods, thence South 40 rods, thence West 40 rods, thence north 25 rods to the place of beginning, containing 10 acres.
2. ALSO commencing at a point in the section line between Sections 17 and 20 Tp. 3 N. R. 8 E. W. M., said point being the SE corner of the 10 acre tract and marked with a stake from which the quarter corner to sections 17 and 20 Tp. 3 N. R. 8 E. W.
