DECLARATION OF HOMESTEAD

STATE OF WASHINGTON)
COUNTY OF CLARK) ss.

KNOW ALL MEN BY THESE PRESENTS: That on this 23rd day of October, 1945 CHARLES M. KIEDROWSKI and BERTHA KIEDROWSKI, husband and wife now and at all times since the date of acquiring title to the following described real property and being residents of Skamania County, State of Washington and the identical persons making this DECLARATION OF HOMESTEAD, and that they are the heads of a family consisting of themselves and two minor children.

That we reside in Skamania County, Washington and we own in our own right the following described tract of land located and being in Skamania County, State of Washington, described as follows, to-wit:

All that portion of the Northwest Quarter (NW $\frac{1}{4}$) of Section Thirty-two (32) in Township two (2) North, Range five (5) East of the Willamette Meridian, lying on the Northwesterly side of the county road known as Shields Road, containing one hundred (100) acres more or less.

That said real estate and premises are owned by these parties and are used exclusively for a home and dwelling house by claimants and their family and that we have not nor either or us heretofore made a Declaration of Homestead and we make this declaration for the joint benefit of ourselves and our family and select the above described property and the whole thereof together with the buildings, improvements and appurtenances thereunto belonging as a Homestead, exempt from execution and forced sale under the laws of the State of Washington.

That we reside upon said property and premises with our family and intend to so reside and which property will not be devoted exclusively to any other purpose and that the value thereof together with the improvements thereon does not exceed \$3500 and that the actual cash value of claimant's equity in said property does not exceed the sum of \$3500.00.
