their costs and disbursements, including a reasonable sum as attorney's fee to be fixed by

The Vendors agree that upon payment of the installment of principal due April 1, 1945, they will furnish the Vendees an abstract of title or title insurance at their option showing merchantable title to said premises in the Vendors. The Vendees have have thirty days for examination of said abstract of title or title insurance and thereafter the same shall remain in the possession of the Vendors until final payment of principal.

Upon payment of one-half of the principal, this agreement then being in force and not in default, the Vendors will upon demand execute and deliver unto the Vendees a Warranty deed to said premises and accept from the Vendees a purchase price mortgage for the balance of the purchase price payable in the same manner and at the same time as herein provided.

Time is of the essence of this agreement, but acceptance of any installment after the same shall become delinquent shall not be construed as a waiver of this covenant as to any subsequent default.
