Warranty Deed.

The Grantors, Lee M. Miller and Della B. Miller, husband and wife, for and in consideration of the sum of Ten (\$10.00) Dollars to them in hand paid, the receipt whereof is hereby acknowledged, do hereby convey and warrant unto Ray Thagon and Helen Thagon, husband and wife, that certain tract or parcel of real property situate in the County of Skamania, State of Washington, and particularly described as follows, to-wit:

Beginning at the southwest corner of Section 18, Township 1 North of Range 5 East of the Willamette Meridian, and running thence West 145 feet, thence North 681 feet, thence West 15 feet, thence North 35 feet, thence East 15 feet, thence North 604 feet, thence East 145 feet, more or less to the line between Sections 17 and 18 of said township, thence south on said line 1320 feet, to the point of beginning, reserving unto the grantors however the right of ingress and egress, and access to a certain spring that is north 960 feet, and west 39.5 feet from the southeast corner of said section 18, together with one-half of the flow of said spring, providing that the existing installation of the Grantees herein shall not be affected thereby; and reserving an easement for the maintenance of a water line from said spring 5 feet in width, the center line of which easement is described as follows:
