KNOW ALL MEN BY THESE PRESENTS, That the Grantor Skamania County, known by its Board of County Commissioners, Skamania County Court House, Stevenson, Skamania County, Washington for and in consideration of One (\$1.00) Dollars in hand paid, the receipt whereof is hereby acknowledged, conveys and quitclaims to the State of Washington, all interest in the following described real estate situated in Skamania County, in the State of Washington:

All that portion of Lot One (1), Block One (1) of the Original Townsite of Underwood, in Township 3 North, Range 10 East, W. M., lying and being Southwesterly of a line drawn parallel with and 50 feet distant Northeasterly, when measured at right angles from the center line survey of said highway.

This deed is made, executed and delivered by the undersigned Board of County Commissioners of Skamania County, Washington, in compliance with, and according to, that certain resolution of said Board adopted June 17 1946, in which the Board unanimously determined to deed the property herein described, to the State of Washington in accordance with Chapter 266, Session Laws of 1943. the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval March. 6, 1934 - Revisions May 21, 1946
