KNOW ALL MEN BY THESE PRESENTS, That the Grantor Mary V. Lane, a widow, of Underwood, Skamania County, Washington for and in consideration of One (\$1.00) Dollars, in hand paid, the receipt whereof is hereby acknowledged, conveys and quitclaims to the State of Washington, all interest in the following described real estate situated in Skamania County, in the State of Washington:

All that portion of a tract of land to be hereinafter described, lying and being Southwesterly of a line drawn parallel with and 50 feet distant Northeasterly, when measured at right angles, from the center line survey of said highway.

The hereinbefore mentioned tract of land is situated in Lot Two (2), Block One (1) of the Original Townsite of Underwood in Township 3 North, Range 10 East, W. M., and described as follows: Beginning at the Southeast corner of said Lot Two (2); thence Westerly along the South line of said Lot Two (2) three feet and ten inches; thence in a Northerly direction in a straight line to the Northeast corner of said Lot Two (2); thence in a Southerly direction along the Easterly line of said Lot Two (2) to the point of beginning.

It is understood and agreed that the delivery of this deed is hereby tendered and such tender kept good until revoked but that the terms and obligations hereof shall not become binding upon the State of Washington unless and until accepted and approved hereon in writing for the State of Washington, Department of Highways, by the Chief Right of Way Agent
