Warranty Deed

The Grantor, Lela C. Nance, a single woman, for and in consideration of the sum of tendollars (\$10.00) in hand paid, and other good and valuable consideration, conveys and warrants to Albert Rumpff and Aili Rumpff, husband and wife, the following described real estate, situate in the County of Skamania, State of Washington:

That portion of the Northeast Quarter of the Southeast quarter of Section 26, Township 2 North, Range 6 East of the Willamette Meridian, described as follows:

Commencing at a point 700 feet South and 360 feet West of the one-quarter corner of the east line of said section 26, which said point is on the west boundary line of State Highway No. 8 where there is a post of fir 3 inches in diameter marked "S" bearing from a fir tree 8 inches in diameter 22 feet Northeast from said post also marked "S" meaning the south corner; thence from said post in a southerly direction along the westerly line of said State Road No. 8 a distance of 50 feet; thence North 74° West a distance of 300 feet; thence North 16° East a distance of 50 feet; thence North 74° West a distance of 257 feet; thence north 16° East a distance of 350 feet more or less to the southerly boundary line of the Kuffler Road; thence in an easterly direction along the southerly line of said Kuffler road to intersection with the westerly line of said State Highway No. 8; thence in a southerly direction to the place of beginning along said highway.
