Permit to Waste Earth Materials

In the matter of Primary State Highway No. 8, Stevenson at East City Limits

Know all men by these presents, that George H. Hathaway and Viola A. Hathaway, husband and wife, of Stevenson, Skamania County, Washington for and in consideration of the sum of Ten (\$10.00) Dollars, in hand paid, the receipt whereof is hereby acknowledged, do hereby grant and warrant unto the State of Washington the right, privilege and permit to waste, place and deposit earth materials of all types and quantities upon the hereinafter described lands, at any and all times from date hereof until August 9th, 1948, said lands being situated in Skamania County, State of Washington, and described as follows:

Lot Four (4) in Block Six (6) of Riverview Addition to the Town of Stevenson, according to the original plat thereof, on record in the Skamania County Court House, Stevenson, Skamania County, Washington.

The specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia, Washington, and bearing date of approval July 16, 1946.

The right, privilege and permit of ingress and egress over and across other lands owned by the Grantor herein, and not hereinabove described, for a haul road of sufficient width to conveniently transport said earth materials, is also hereby granted to the State of Washington by the Grantor herein.
