Elin Lowe now Melendy et al. to George M. Hazard et ux

The Grantors, Elin Lowe (now Melendy) dealing with her separate property, and George S. Nielsen, a single man, in consideration of the sum of one dollar to them in hand paid do hereby bargain, sell and convey unto George M. Hazard and Stella M. Hazard, husband and wife, Grantees, the following described real property in Skamania County, Washington, to-wit:

Commencing at the point of intersection, as of December 31, 1923, of the west bank of Duncan Creek in Section 34 tp 2 N. R. 6 E. W. M. with the northerly line of the North Bank Highway, thence southwesterly along the northerly line of said highway a distance of 60 feet, to the point of beginning of the land hereby described; thence from said initial point northwesterly parallel to the west bank of Duncan Creek, and along the westerly line of that tract of land formerly owned by Mary M. Reath, a distance of 100 feet, thence southwesterly parallel to the north line of said North Bank Highway a distance of 100 feet, thence southwesterly parallel to the west bank of Duncan Creek a distance of 100 feet to the northerly line of said North Bank Highway, thence northeasterly along the northerly line of said North Bank Highway a distance of 100 feet to the place of beginning.

And the said Elin Lowe does hereby covenant and agree with the said grantees, their heirs and assigns, that she is the owner in fee simple of all the westerly 60 feet of said tract of land and that she will, and her heirs, executors and administrators shall, forever warrant and defend the title thereto against all lawful claims whatsoever, save and except easement for that part of the North Bank Highway included within the bounds thereof.
