Whereas, Gladys T. Reynolds and J. J. Reynolds, her husband, and the Underwood Fruit & Warehouse Co., a Washington corporation, executed an instrument entitled "Deed, Easement and Agreement", dated the 5th day of January, 1938, and recorded in the office of the Auditor of Skamania County at 8:20 A.M. on January 24, 1938 in Book Z of Deeds at page 596 thereof, and

Whereas, J. J. Reynolds is now deceased, and

Whereas, Gladys T. Reynolds and the Underwood Fruit & Warehouse Co. desires to modify the aforesaid "Deed, Easement and Agreement" by extending the same under the following terms and conditions:

NOW THEREFORE:

Said "Deed, Easement and Agreement" is to be operative, and, except as herein provided, continues the rights and obligations therein mentioned to and including August 12, 1968.

Payments by the Underwood Fruit & Warehouse Co. are to be in the sum of Two Hundred Forty Dollars (\$240) per year and are to be made on or before August 12 of each year. Payments are to be made one year in advance as in the above referred to "Deed, Easement and Agreement" and the last payment is to be made on or before August 12, 1967.

If the grantee, for any reason, ceases to carry out its cold storage plant and warehouse operations in a manner which requires approximately the amount of water which it has customarily taken from the springs referred to in the aforementioned "Deed, Easement and Agreement", the provisions of said "Deed, Easement and Agreement" shall at the option of the Underwood Fruit & Warehouse Co., be cancelled and made null and void.

It is further understood and agreed that provisions of this instrument and the aforementioned "Deed, Easement and Agreement" shall inure to the benefit of and be binding upon the heirs, executors, administrators, successors and assigns of the parties hereto.
